- 3. The undersigned shall protect the electric facilities of the Cooperative within the service area of the Association from being vandalized the continuity of electric service to consumers.
- 4. The undersigned shall support and cooperate with the officers of the association in their task to curtail pilfering of electricity and tampering of electric meters, right of way easement, clearing of distribution lines and other construction that may hamper delivery of electricity or pose danger to life and property.
